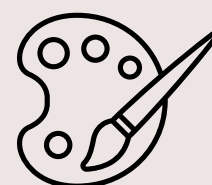
TERMS AND CONDITIONS

Request the template at any reception hotels or download it and start drawing your perfect Christmas



Take a picture of your drawing and don't forget to give it an original title!



Enter the information of the father, mother or legal guardian. / Dad or mom should upload it on the website to participate.

1. Participants

Any person from any region or country may participate, regardless of race, gender, language or religion.

The drawings must be made by children aged between 1 and 12 years (at the time of the competition).

The drawings must be made within the template created for this competition (which will be found in our Eurostars Hotel Company hotels and on the competition website). There are no restrictions on entries. Every child can upload as many drawings as they want.

Each drawing must include a title and the child's name and age. In order to upload it to the competition website, the name, e-mail address of the parent/legal guardian and the title of the illustration are also required.

2. Drawing technique and process

Freestyle. Copies of copyrighted drawings, brands, logos and materials will not be accepted.

3. Entering the drawing competition

To take part in the competition you must:

- Use the official template of the competition and draw what you like most about
- Christmas inside the present's contour.
- Take a picture of the sheet, making sure the drawing can be seen clearly.
- Access the website: www.pintandolanavidad.com and upload the picture of the drawing and fill in all the relevant fields.

By publishing the drawing on the website www.pintandolanavidad.com you accept the legal terms of this competition.

When registering and by accepting these terms and conditions, you authorize the publication of names and surnames on the competition website and on the social networks of Eurostars Hotel Company, in the event of winning a prize, without the need for prior confirmation.

4. Duration of competition and voting

It will take place from 5 December to 10 January 2023. During the following days, the winner will be selected and informed.

It is only allowed to vote to 3 participants just one time. Be aware that if the IP of the device is the same with another the vote will count as the same user, so you can subtract or not count that vote.

5. Prizes

Prize category between 7 and 12 years: The most creative illustration that best conveys the Christmas spirit will win a stay for four people, including breakfast, at a Eurostars hotel for all the family. The First Prize will be chosen by an in-house panel.

Special Public Vote Prize: The illustration that gets the most votes will be the winner of a two-night stay for four people, with breakfast included, at a Eurostars hotel for all the family.

6. Image rights and intellectual property

In compliance with Organic Law 1/1982, of 5 May, on the civil protection of the right to honour, personal and family privacy and one's own image, it is established that participation in the competition implies:

In view of the under-age status of the authors of the drawings, the participants in the competition, whether they are winners or not, state that (i) the drawings presented are original and that the creative concepts and/or creations that compose them have not been made by third parties who are not participating in the competition and (ii) do not infringe rights of third parties. In the event that any third party claims copyright on any of the drawings submitted by the participants in the competition, Eurostars Hotel Company will be exempt from any liability.

The participants, whether they are winners or not, authorise Eurostars Hotel Company to disseminate the drawings and use the data provided with the drawing in any advertising and/or promotional activities related to the Drawing Competition or related activities, without said activities giving them the right to remuneration or any benefits, except for the receipt of the prize, if applicable, in accordance with these terms and conditions.

All participants, whether they are winners or not, who upload drawings to social networks, authorise Eurostars Hotel Company to publish in the media it deems appropriate all the submitted drawings.

Participants transfer to Eurostars Hotel Company exclusively and without restrictions of any kind, all intellectual and industrial property rights for the use and reproduction of the drawings, whether winning or not. As a result of the transfer of usage rights, Eurostars Hotel Company is responsible for the exclusive operating rights of reproduction, distribution, public communication and transformation through any means of the winning drawings of the competition. The transfer of said rights is carried out without any geographic or time limits.

Eurostars Hotel Company retains all property and usage rights for the winning drawings. The above transfers are understood to be made free of charge. Eurostars Hotel Company reserves the right not to publish any drawing whose content is not related to the competition subject or any drawing whose authorship is suspected of not being of the registered child.

7. Personal Data Protection

Pursuant to the provisions set out in Regulation (EU) 2016/679 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 27 April 2016, the General Data Protection Regulation (GDPR), and in Law 3/2018, of 5 December, on Personal Data Protection and Guaranteeing Digital Rights, you are hereby informed that the entity responsible for processing participants' personal data is EUROSTARS HOTELS COMPANY, S.L., which has its registered office at Carrer Mallorca, 351, 08013, Barcelona, as organiser of the drawing competition, Painting Christmas 2022.

The purposes of processing are as follows:

(i) To manage participation in the prize draw in accordance with the terms set out in the Rules, as well as to assign the prizes obtained.

(ii) To reproduce and use the drawings obtained during the competition for advertising and not-for-profit purposes.

The legal basis for processing the personal data is the consent granted by the interested party to pursue their participation in this drawing competition. The categories of personal data that will be processed are identification information (name, surname/s, age) and contact details (email address of the parent or legal guardian).

The recipients of the personal data processed in the scope of this activity will be EUROSTARS HOTELS, S.L. and all other companies in the HOTUSA Group. No international personal data transfers are anticipated, except those required for storage purposes, which are always to entities that have proven they comply with the level of protection and guarantees required according to the parameters and demands set out in applicable data protection regulations, or when there is legal authorisation to make the international transfer.

The personal data of competition participants will be stored until the purpose of processing (for which they were collected) has come to an end, and while the terms for lodging any civil, criminal or administrative appeals in relation to the same have not yet come to an end.

You may contact the data controller, as well as exercise your rights of access, rectification, erasure, data portability, limitation, opposition and withdraw consent, by writing to the data controller's address or emailing dpo@grupohotusa.com. You have the right to file a claim with the Spanish Data Protection Agency if you deem it appropriate.

- Shorten, extend, modify or cancel the competition, with good cause beyond the control of Eurostars Hotel Company, and of an external nature.
- Disqualify participants who do not comply with the conditions established in the third condition of these legal terms.

Ban candidates that, during their participation in the programme, show any of the following attitudes and behaviour that: (1) threatens the safety of children, youth or women; (2) invades or damages the privacy of a third party; (3) induces, incites or encourages any type of criminal, denigrating and/or violent acts in any of its forms; (4) includes violent or pornographic messages; (5) is in possession of a virus or other computer codes, files or programs designed to interrupt, destroy or limit the operation of any software, hardware or telecommunications system.
